

### WHOLE MILK IS BACK

The Whole Milk for Healthy Kids Act, introduced in the Senate by Senator John Fetterman and colleagues, will now allow schools participating in the National School Lunch Program to serve whole and reduced fat milk. This bill was signed into law by President Trump.

*"This is a commonsense bill that benefits everyone. PA farmers supply the country with some of the best milk year-round, and instead of limiting choices in our schools, this will expand the nutritious and healthy options for our kids," said Senators John Fetterman and Dave McCormick.*



### Fetterman, Colleagues Introduce Legislation to Cap Credit Card Late Fees at \$8

U.S. Senators John Fetterman (D-PA), Cory Booker (D-NJ), and Tammy Baldwin (D-WI) introduced the Credit Card Fairness Act, legislation that would put into statute the Consumer Financial Protection Bureau's popular \$8 cap on credit card late fees. [Read More.](#)



### The School Access to Naloxone Act


This bill would authorize grants that support expanded access to drugs or devices to treat opioid overdoses in elementary and secondary schools, ensuring schools have trained staff on the premises during operating hours who can administer it.

### The On-Scene Care and Support (EMS ROCS) Act


This bill would amend the Social Security Act to provide Medicare reimbursement for care provided by EMS when no transportation to the hospital is provided. Currently Medicare only reimburses for EMS services if patients are transported to the hospital via ambulance.

### Fetterman, Colleagues Reintroduce Bill to Reduce Barriers to Organic Agriculture

The Opportunities in Organic Act would help farmers and other agricultural producers transition to organic practices and build successful and sustainable businesses. This legislation would help eliminate steep barriers farmers often face to enter the industry, including high certification costs and insufficient technical assistance from existing United States Department of Agriculture (USDA) programs. 

**Free tax preparation and assistance are available:**

- [IRS Free File](#) and Fillable Forms. The IRS Free File program will begin accepting individual tax returns starting Friday, Jan. 6 for qualified taxpayers.

Taxpayers comfortable preparing their own taxes can use [IRS Free File Fillable Forms](#) starting Jan. 26, regardless of income.

- [MilTax](#). Military members and some veterans can use the Department of Defense program, MilTax, for free return preparation and e-filing software.

- IRS-certified volunteers. [The Volunteer Income Tax Assistance and Tax Counseling for the Elderly](#) program offers no-cost, basic tax preparation to qualified individuals.
